Apart from community pharmacy services, we collaborate with other community organizations, professional bodies and academia to drive the development of primary care pharmacy service through cycles of "service, research, advocacy and education". We strive to achieve health equity in society through a medical-social collaboration and transdisciplinary model.

Key Responsibilities:

- To support the operations, compliance to legal requirement, inventory management of a community pharmacy (i.e. Authorised Sellers of Poisons)
- To deliver minor ailment services and medication management services, including medication reconciliation, medication review, teleconsultations to patients with chronic diseases and their caregivers
- To contribute to the holistic patient care and services at HIA as a team member of transdisciplinary team
- To engage patients and caregivers via educational activities and community support programmes
- To work with the Department of Pharmacology and Pharmacy, The University of Hong Kong on a service-based research project and on-site training (e.g. student placement)

### **Qualifications:**

- Registered pharmacist with valid practising certificate in Hong Kong
- Newly registered pharmacist are welcome to apply
- Work experience in community pharmacy or non-governmental organisations, and postgraduate education in health-related discipline are advantages
- Experience in social engagement and transmedia campaigns would be a bonus
