Kwai Tsing Community Health Management Hub is a primary healthcare programme comprising social and medical services. It provides “one-stop” health management service to the citizens in Kwai Tsing district, aiming at enhancing the health knowledge and ability to self-manage disease.

Job Description:

- Lead the development of the community pain management service.
- Assess service users' physical and chronic pain conditions, taking into account social determinants that may impact their health.
- Create personalized pain management plans incorporating motivational elements to empower service users in self-managing their health.
- Guide the team in designing and implementing outreach services.
- Provide education and exercise prescriptions to service users, focusing on injury and fall prevention as well as healthy living tips.
- Design, organize, and oversee physiotherapy services and health management programs in collaboration with a transdisciplinary team.
- Actively engage in the development, design, and implementation of services to address the health management needs of service users.
- Stay informed about the latest research and trends, applying relevant findings to the project.
- Offer expert guidance and training to internal stakeholders.
- Coordinate health-related programs in partnership with external organizations, including NGOs, restaurants, and workplaces.
- Consolidate knowledge related to community physiotherapy services and transdisciplinary collaboration for effective project knowledge management.
- Undertake additional duties as assigned by HIA delegates.

Requirements:

- Degree holder in Physiotherapy or equivalent.
- Holder of Certificate of Registration (Part 1a) with valid practicing certificate issued by Physiotherapists Board of Hong Kong.
- Post graduate qualification / Cert. in Acupuncture is an advantage.
- A minimum of 2 years of experience in a community or primary healthcare setting, with a proven ability to contribute to overall service development
- Strong ability to build and maintain rapport with clients.
- Patience and tolerance in client interactions.
- Proficient in common computer applications, including Google Workplace and MS Office
- Excellent command of both written and oral English and Chinese preferably including Putonghua
