Job Description:

- Support the functions and operations of the Community Pharmacy and ensure compliance with the standard operating procedures/guidelines as well as all legal requirements.
- Assist our pharmacists to dispense medications accurately and efficiently, including prescriptions, over-the-counter (OTC), and health supplements for medical treatment, disease prevention, and response to minor ailments
- Handle phone and online enquiries from clients
- Responsible for procurement and inventory management of medications, consumables, and equipment, ensuring timely orders, secure storage and compliance with regulatory requirements
- Handle expired medications according to the standards of relevant authorities.
- Perform monthly medication stock counts and expiry checks.
- Take up other ad-hoc assigned from the Pharmacist-in-charge and the management team.

Qualifications:

- Higher Diploma in Dispensing Studies or related discipline or above.
- Experience in medication procurement is preferred.
- 2+ years of working experience in a community pharmacy or clinic environment will be an advantage
- Good communication, problem-solving, and interpersonal skills
- Good command of Chinese and English language (written and spoken).
- Strong sense of responsibility, a good team player, and able to work under pressure.
