Health In Action is seeking a dedicated and culturally sensitive Multicultural Health Officer to support our mission of promoting health equity across diverse communities. This role involves direct community engagement, program development, and collaboration with stakeholders to improve the health outcomes of multicultural populations.

Key Responsibilities:

- 1) Health Assessments and Promotion:
 - Conduct comprehensive health assessments and screenings for service users in both outreach and center settings.
 - Deliver personalized advice on healthy lifestyles tailored to multicultural communities.
 - Develop culturally appropriate health communication and educational materials focused on health promotion and risk reduction.

2) Program Design and Implementation:

- Design and implement health promotion and lifestyle modification programs tailored to the needs of multicultural service users, under the guidance of a dietitian.
- 3) Communication and Support:
 - Provide interpretation and translation services to facilitate effective communication with multicultural service users.
 - Assist in outreach and engagement with non-Chinese speaking target groups.

4) Service Management:

- Manage walk-in, phone, and email inquiries promptly and professionally within outreach and center environments.
- Coordinate scheduling and make appropriate service referrals efficiently.
- Compile and maintain service and activity reports.
- Support the upkeep of information management systems to ensure data accuracy and quality.

5) Stakeholder Collaboration:

 Build and maintain partnerships with external stakeholders such as restaurants, workplaces, and schools to advance community health initiatives within multicultural populations.

6) Additional Duties:

 Perform other duties as assigned by the management team to support the organization's goals.

Qualifications:

- Bachelor's degree in Public Health, Community Health Practice, or a relevant health-related field from a recognized institution locally or abroad.
- Prior experience in multicultural community health or within non-governmental organizations is highly desirable; fresh graduates are also encouraged to apply.
